The hosted solution should look just like your desktop software (ask for a <u>free</u> <u>custom demo!</u>), so no training is required. - A complete overview of their technology and security standards. Many low-priced
  offers sound appealing but aren't built to high-quality standards. To protect data and
  ensure a good customer experience, it's best to bypass cheaper providers and spend
  a few extra dollars per month to guarantee top-notch service and security.

Before signing on the dotted line, ask for a quote that breaks down the costs item by item so you know exactly what to expect out of the service.

#### **Question 9: Are You an Authorized Intuit Hosting Provider?**

Intuit, the company behind QuickBooks, has endorsed a select number of hosting providers as Authorized Partners.
